of 1917. He is noted for his dialectics of economic evolution. According to him, the contest between organized labor and centralized capital would end by giving way and handing over complete power to the production of the state.

Karl Marx was strongly supported by his associates, Lossily Angels and Rod Butters.

stages of community development for stage, which is

dominant class. The second stage is the social development in the

of service. The third stage gave rise to the merchant middle

It is this stage of social and economic development which
characterizes all advanced modern and non communist
communities. At this stage the domination passes from the

Final stage Marks and massages. This stage where in the development of socialization of society leads to the stage of perfect communism. Here all thecapitalist and the bourgeoisie element have been eliminated. This stage may come either by evolution or by revolution.

Law the interpretation of law as part of an economic interpretation of social evolution is byproduct of the social and political theories of Marx and Angels.

Marx believed that this social phenomenon was governed by universal principle, namely economic principle. He was a social scientist and sought descriptive propositions about social evolution. He believed that law is an instrument by which minority exploit the workers. The tension between the capitalist and labor would eventually break into a conflict. Here, the majority would take control of the economic resources and would seek to eliminate the minority.

The state thus established is the proletarian dictatorship.

This is referred by Marx as highest form of democracy possible in a class society.

The proletarian dictatorship is indeed a dictatorship, but insofar as it has been formed by the masses, it acts in their interests in democracy.

From this the following doctrines can be deduced.

Doctrine of the economic determination of law according to Marx ideas are reflections of society. The notion that law is a reflection of an economic substrate is not an ideology.

For it accords with reality.

Doctrine of the class. Character Of law Law is an instrument used by the economic rulers to keep the masses in subjection.

Even after the establishment of the proletarian dictatorship, low will continue to be as the instrument by which working class majority can crush and eliminate the minority.

Law will always be instrumental

of domination. Third, one, the doctrine of identity of law, an state the state came into existence as soon as there was unequal distribution of

commodities. Law was a means by which capitalist minority sought to protect those who had
